1. EL LUGAR PRIVACY POLICY

3.2. Protection of El Lugar and Others

This includes exchanging information with other companies and organizations for fraud protection and credit risk reduction. 5. HOW SECURE IS INFORMATION ABOUT ME?

5.1. We work to protect the security of your information during transmission by using Secure Sockets Layer (SSL) software, which encrypts information you input.

5.2. We reveal only the last four digits of your credit card numbers when confirming an order. Of course, we transmit the entire credit card number to the appropriate credit card company during order processing.

5.3. It is important for you to protect against unauthorized access to your password and to your computer. Be sure to sign off when finished using a shared computer.

6. WHICH INFORMATION CAN I ACCESS?

El Lugar gives you access to a broad range of information about your account and your interactions with El Lugar for the limited purpose of viewing and, in certain cases, updating that information.
